This has reference to your application submitted for recognition under Hygiene Rating Audit Agency Scheme on 15/01/2024.



3. QCI shall issue letter of recognition for a period of three years as defined in the scheme based on the successful completion of witness assessment.
4. Agency shall comply with all the applicable requirements, criteria, man-day, fee structure, guidelines for use of QCI logo and other guidelines available for reference on the QCI website [www.qcin.org](http://www.qcin.org)
5. Agency shall comply with all the updated guidelines or requirements issued by QCI/FSSAI under HRAA Scheme.
6. Agency shall comply with the signed agreement/undertaking during the period of provisional recognition, failing to the comply shall lead to suspension/withdrawal/termination of provisional recognition as applicable.
